General Information and Terms

No court time will be held if full payment is not received by October 11, 2021. The person that signs the contract is responsible for payment and any court not paid in full by day one will be removed from the schedule. This will be strictly enforced. Court time will be assigned on a first-come, first-served basis for new players.

All seasonal court time and/or tennis lessons can only be sold and booked by the PPTC.

This reservation form allows you to use a court designated by the PPTC for the allotted time and day indicated above for the entire 2021-2022 indoor tennis season. The indoor season runs October 18, 2021-May 1, 2022.

The signer of this contract is responsible for all payments toward seasonal court time as outlined above. PPTC will not accept payments from players other than the signer of this seasonal contract.

If payment is not received by required due dates, your seasonal court time will be released for sale to the public.

In the event that you are unable to keep any of your reserved seasonal court times, you can notify the PPTC in advance and the PPTC will make every effort to resell that time. There are no guarantees that the PPTC will resell that time, and there will be no refunds if the time remains unsold. If the court is resold, PPTC will attempt to schedule a make-up session for you in an equivalent time period during the 2021-2022 indoor season.

Seasonal court time can only be resold through the PPTC.

All players are required to abide by the rules set forth for tennis play at the PPTC.

A signed contract and the total seasonal court cost must be received in advance to reserve your time and court.

No court time will be held if full payment is not received.
