Boating Rules and Regulations

- By purchasing this admission ticket, you are aware that boating involves certain inherent risks, which may cause serious injury. You freely volunteer to participate and accept all known and unknown while on the lake in a rowboat or kayak. Further, you release the facility, its sponsors, its operators and its equipment suppliers against any claims and all liability for any loss, damage, injury or expense you may incur. **NO REFUNDS, NO CREDITS. NON-TRANSFERABLE. NO REPLACEMENTS**
- No swimming or wading in the lake at any time..
- No private boats of any kind are allowed on the lake.
- All island access is prohibited. Do not dock or land on any of the islands in the lake. Islands are considered fragile wildlife habitats and are not for exploring..
- Do not harass or feed the wildlife. Waterfowl and other aquatic species are to be observed from a distance only. Following, picking up or throwing things at them is prohibited..
- Avoid areas of aquatic vegetation. Do not go into the lily pads (the boat can easily get stuck).
- No boating around the Terrace Bridge.
- No fireworks are permitted anywhere within Prospect Park.
- No horseplay. No roughhouse, No fooling around. No standing, rocking, or switching boats.
- No food or beverages allowed on any rowboat or kayak.
- No smoking anywhere or at any time in Prospect Park.
- While on any rowboat or kayak, no talking on cellphones, or holding cellphones, and no use of any portable electronic devices, i.e., cameras, iPods, headphones, ear buds, etc.
- Behavior in a manner that, in the opinion of management or staff, endangers or interferes with other boaters' safety or pleasure, is strictly prohibited. Violation of this rule may result in ejection from the facility.
- Boaters are not permitted to carry or bring with them such items as handbags, cross-body bags, cameras, backpacks, cell phones or any other hand-held object. Please use the lockers which are provided for your convenience.
- Rowboats and kayaks are available on a first-come, first-served basis.
- Malicious incidents or destruction of property must be reported to boat staff immediately.
- Management is not responsible for personal items missing, lost, stolen or left within or near boat rental area or at the facility..
- Report any injuries or hazards to staff immediately.
- All participants must sign a waiver (if you're under 18, a parent or guardian must sign the waiver for you).
- A staff member will assign your rowboat or kayak, go over our boating rules and assist you with launching your boat or kayak.
- Life jackets will be given to you and must be worn at all times while on the water. Individuals less than 36" in height are not permitted unless life jacket fits. **Life Jackets are Mandatory. No exceptions.**
- Stay in designated boating zones. No docking or landing outside marked areas.
- Infants or babies are NOT allowed on any boat or kayak.
- Alcohol and drug use is prohibited. If you violate this rule, you'll be asked to leave immediately.
- One or two people per kayak; up to two people per rowboat.
- No fishing from any boat at any time.
- Paddle responsibly and be aware of other boaters.
- When your time is up, return promptly to the dock.
- Please return all paddles and life jackets to the designated area.
- Do not litter... help us keep the water clean.
